**CANCELLATIONS**—The SC shall give Artist (30) days written notice prior to scheduled performance(s) of any cancellations.

**REPRESENTATIONS, USE OF PRESENTATIONS, AND PROMOTIONS**—Artist represents and warrants that the Presentation consists of original material which does not violate copyright or other laws or statutes and that Artist has the legal ability to assign to SC the rights referenced in this paragraph. Artist authorizes SC the rights to use Artist's name, biography, photograph(s) and likeness for advertising, press, and promotional purposes by any means or medium. **Please see separate digital release form.**

**INDEMNIFICATION**— The Client shall indemnify and hold harmless Artist against any and all claims, demands, suits, judgments or sum of money, to any party accruing against Artist for loss of life, injury or damage to persons or property arising out of, resulting from, or by reason of any act of omission of the Artist while engaged in or about, or in connection with, the discharge of the performance of services to be done. **Please see separate COVID liability waiver form.**

**FORCE MAJEURE**—In the event of inclement weather, labor disputes, walkouts, pandemics, or any other condition beyond either party's control, neither party shall be liable to fulfill the remainder of the Agreement or provide any "makeup" date unless expressly agreed upon by both parties for a convenient future time.

**TERMINATION OF AGREEMENT**—Any party to this agreement may terminate this agreement by giving the other party written notice by mail of said intention. Nothing in this paragraph shall be construed to limit the obligations of the Artist under the "Cancellations" paragraph.
